12 DETAILED STATEMENT OF FACTS/CONTENTIONS OF THE GRIEVANT

During the week of 5/12 - 5/18/07, the USPS violated the NA when they expanded the work hours of the PTR's in Anytown, NC. All PTR's have a six-hour per day, six-day per week duty assignment. All PTR's were worked beyond their six-hour per day schedules each day of their work week. The USPS failed to utilize the OTDL and there was no emergency or unforeseeable condition in existence that week. The OTDL clerks were qualified and available to perform the work in question.

The APWU requests to be made whole in every way including 1.) All PTR's be paid an additional 50% for those hours worked outside of/beyond their posted schedules; 2.) All OTDL clerks be paid for those hours worked by the PTR's in excess of their schedules at the appropriate OT rate; 3.) USPS cease and desist violating the NA.
