Secretary's Report

The meeting of the APWU Local 451 was called to order at 11:15am. at the OP with 15 members and retiree Stan Drewelow present.

A **motion** was made by Jerry Kemmer and seconded by Glenn Staudinger to accept the minutes as printed in the Corner Stone. **Motion carried.**

The Treasurers Report was read by Glenn Staudinger A **motion** was made by Glenn Staudinger to put the report on file for review. The motion was seconded by Jerry Kemmer. **Motion carried.**

Officers Reports:

Presidents Report:

1. COPA-Dwight received a notice from the COPA Coordinator in New Jersey, that Waterloo was indeed the top donor in the nation (per capita). Also, we were at the top for all offices of our size. Get your COPA raffle tickets. There are many nice prizes to be drawn for in the months to come. You do not have to be present to win.
2. Tri State- Dwight learned that we are supposed to end up with 9 casuals. Most of our (PTFs) should be converted soon or by now.
3. New hires will now all be full time regulars. They will be unassigned regulars for 120 days, then a duty assignment will be posted for them.
4. By the end of the year there should be no more loaners coming into our office except at the window.
5. Dwight stated that hopefully there will soon be a passport and claims job posted.
6. Our 2 remaining PTFs will be converted soon.

Vice President:

Kim Karol stated that in 1970, 90% of the population was responsible for 2/3 of the GNP of the U.S. The top 10% grew in 1970 from 33% to 48%. The top 1% of the national incomes grew from 1% to 5%. Of this 1% the

top 100 make \$24 million dollars a year or 560 times more what we are getting paid. They are trying to correct this national trend through legislation. Watch for HR300 or Employee Free Choice Act. We the people need to reverse this trend so that we are not paying for everyone.

Editor:

Chris Salinas commented that HR300 is stuck in the Senate right now so we need to contact our Senators and let them know how you feel. Also, we need to send E-mails to the White House at:

Chris also stated that we need to contact our Representatives at the State House and tell them that we want the (SF413) Fair Share Act passed. Cindy Miller stated that she received a phone survey concerning the Fair Share Act If you get a call like this please take the time to answer their questions, they are very general in nature.

Kim Karol stated that we need to be watching for legislation concerning Healthcare Tax. We do not want our Health Care Benefits taxed no matter what our incomes are. The employee's voice needs to be loud and vocal.

The web site to contact the State Legislators is www.legis.state.ia.us. Chris will post it on the board.

A **motion** was made by Kim Karol and seconded by Gary Acuff for the union to purchase the few extra sweatshirts needed to get the cheaper rate. **Motion carried.**

Cindy Miller stated that we need to get along with the casuals. She also stated that we are responsible for watching our paychecks.

Old Business:

The next meeting will be held on Saturday April 21, 2007 at 11:00 am. at the OP.

New Business:

1. Dwight stated that we are supposed to get our retroactive pay sometime in May. A **motion** was made by Paulette Woods and seconded by Chris Salinas to waive our portion of union dues out of our pay for the retroactive time period. **Motion carried.**

2. The postmaster has decided he wants to open negotiations for our local contract. He will let Dwight know when within the period of April 2 through May 31st. A motion was made by Kim Karol and seconded by Gary Acuff to authorize up to 7 people established by the president for LWOP for participating in the local negotiations. Kim accepted a friendly amendment by Chris Salinas in which he wants one of the representatives to be from the maintenance craft. Kim Karol called for the question to end discussion. **Motion carried.** The main **motion carried** also.

A **motion** was made by Bonnie Salinas and seconded by Kris Engelmann for the union to donate \$100.00 to MDA. The motion was defeated 5 for - 8 against 1 abstained.

Drawing: A **motion** was made by Paulette Woods and seconded by Chris Salinas to hold the drawing for the door prize. **Motion carried.** Julie Schmitz won !!!!

Adjourn: A **motion** to adjourn was made by Jerry Kemmer and seconded by Kim Karol to adjourn. **Motion carried.** The meeting adjourned at approx 12:45 pm.
