

We'll be looking not only for delegates but also a few volunteers to help with registration, hospitality rooms, etc. This will be the full State Convention during which delegates will be assigned to committees authoring resolutions and constitutional changes to be sent to the National Convention later in the year. The convention also includes state elections so if you, or someone you know, may be interested in a state office, being a delegate will put you into position for nomination. I think I brought all this up in previous articles but want to make sure everyone knows about it so we don't miss any volunteers. The convention will take place Friday and Saturday, April 25 & 26, with registration and hospitality taking place also Thursday evening the 24th. So, for the most part, we're looking for help Thursday evening, Friday morning and Friday evening. Anything needed during the day Friday and Saturday can probably be handled by me and our other delegates. We do already have a couple names on the list but could use some more. Let us know if you're interested

and thank you in advance.

We have 3 arbitration cases in various stages of being finished up right now. I went to Des Moines awhile back and testified for one of them. That one has Business Agent Kessler writing up final briefs to be sent to the arbitrator for her decision. The earliest I will start looking for a decision would be mid-February. The second one will be settled prearbitration by Business Agent Foley. While there were management errors that were cause for the filing of the grievance, it is not believed an arbitrator would be convinced to allow the remedy request. Foley will, therefore, attempt to negotiate some language with management which may help if the situation comes up again but he will not be arbitrating it. The third has Business Agent Taff on his way to Waterloo as I write this. He, with Vanda's help, will have arbitrated the case on the 8th. Again, I won't start looking for an answer until at least the middle of February.

I've been hearing reports of discipline being handed out recently. If you are one of them and your Steward is not aware of it, ask to see them ASAP. The discipline issues will be investigated and dealt with as necessary.


Adjourn:
