If you earned less than \$42,000 in 2008, you can receive FREE tax preparation.

You also may be eligible for the Earned Income Tax Credit (EITC). Last year the average refund and EITC was \$1,500! This is your money to keep and save.

The **MAXIMUM** amount of EITC you may qualify for:

- \$ with two or more qualifying children: \$4,824
- \$ with one qualifying child: \$2,917
- \$ with no children: \$438

Keep your hard-earned money by getting your taxes prepared for FREE by IRS trained tax preparers.

After your tax return is complete, you can take advantage of other services like financial coaching and opening a bank account.

- Copies of ALL forms (W-2, 1098, 1099) and amounts of any other income

- Name, address and tax ID number of any child care provider and the amounts paid
